Recruitment Project Update (Martha Duckert)

Highlights of the last few weeks:

A couple of weeks ago, we met with Resumix and learned that the internet interface they'd been working on since fall was nearing completion and they asked us to look at it to see how well it would work for us. (They didn't offer it originally when we contacted them in the fall because we were targeting an April launch and they knew it wouldn't be ready by then.)

An evaluation by the design team indicated that it had sufficient features that it no longer made sense to pursue having ISSC build a duplication of what already existed, but that it made more sense to see how we could have the Resumix online components adapted to our needs. The initial 30-day letter of intent with ISSC was due to expire within a day, so we let that happen.

We are now working with Resumix to define the features the internet interface still needs and how that may be developed. We have a verbal agreement with Resumix that pafet will be the exclusive beta tester of the internet product. We will seek bids from Internet Service providers to host the site - we asked ISSC to bid it, but they declined.

We had a meeting in Dallas, March 4-5, with marketing reps from the Pafet companies to exchange marketing ideas and incorporate them into our plans.

We have a couple of demo disks available: 1) a demo of the current Resumix online product, 2) a demo of the Pafet concept product.

Next Steps

We still have more to do to complete the work necessary to put together a business agreement. We need to complete the reconcilliation of features vs. what's available and develop a plan for filling in the holes, complete reference checks, finalize Resumix license terms, get bids from Internet Serice providers, have legal review, finalize marketing plans, finalize internal system support needs.

We are continuing to try to move quickly, yet carefully - there's a lot of detail to get in sync. We hope we are only a few weeks away from completing this phase - the end of March is our goal.
